SCOPE:

"THE ANVIL" strengthens the Trainee's proficiency of tasks learned during the first six weeks of basic training. Over the next 48 hours, Trainees will receive an external evaluation on establishing a hasty fighting position, gain additional proficiency through repetition on the shoot, move, communicate, and survive tasks learned, and be introduced to fire and movement as a Buddy Team. After the completion of "THE ANVIL," Trainees will have improved proficiency on the shoot, move, and communicate tasks. The Trainees will be ready for the externally evaluated Buddy Team live-fire exercise and force-on-force exercise. Completion of "THE ANVIL" will serve as a transition from White Phase to Blue Phase, symbolically represented by the presentation of the Blue Phase banner.

Motivator

The Anvil represents the forging of a strong foundation and ability to stand against extreme pressures and austere conditions.

The battlefield is forever changing. As a Soldier, you must be able to perform under any condition and in any area around the world. Knowing or having a basic idea of what to expect based on the Operational Environment (OE) better prepares you as a Trainee to meet the challenges faced during times of war. Drill Sergeants will use their experience and various scenarios that represent the Operational Environment (OE) in places the military is deployed around the world.

Safety Requirements

INSTRUCTOR NOTE: The Instructor will brief the unit/site SOP and Risk Management Worksheet for all potential contingencies encountered during each training period/event (i.e., severe weather, fire, evacuation routes, and rally points, etc.).

Safety is paramount in the complex outdoor environment. During the training process, Commanders will utilize the 5-step Risk Management process to determine the safest and most complete method to train. Every precaution will be taken while replicating realistic battlefield conditions. It is everyone's responsibility to recognize, mitigate, and report hazardous conditions.

Risk Assessment Level

Medium - Musculoskeletal injuries.

Assessment: Ensure a copy of FM 7-22 is present for the Drill Sergeants to reference if needed.

Controls: Prior to the execution of training Drill Sergeants will conduct a warm-up IAW FM 7-22.

Leader Actions: Ensure DD 2977 is updated with appropriate controls. Ensure Drill Sergeants have the appropriate information prior to the safety brief.

Medium - Heat/Cold Weather Injuries.

Assessment: Ensure to check local weather reports prior to the execution of the training. The Drill Sergeants must also conduct layouts to ensure all required clothing and equipment are present.

Controls: The Drill Sergeants will monitor the Trainees to ensure they are adequately hydrating and consuming an appropriate amount of nutrition. The Drill Sergeants will ensure the Trainees are wearing the appropriate clothing and protective gear for the local weather.

Leader Actions: Ensure the DD Form 2977 is updated with the appropriate controls.

Medium - Dehydration.

Assessment: Check the water levels in the unit water trailer prior to the execution of the training. Make sure the Drill Sergeants confirm the Trainee's water levels prior to departure.

Controls: The Drill Sergeants will include the symptoms of dehydration in their safety brief. The Drill Sergeants will monitor the Trainee's water consumption.

Leader Actions: Ensure the DD 2977 is updated with the appropriate controls. Ensure the Drill Sergeants possess the appropriate information prior to the safety brief.

Medium - Inclement weather.

Assessment: Check the local forecasts. Contact range control for more detailed information.

Controls: The Drill Sergeants will brief the Trainees on what course of action to take for specific weather conditions (i.e., lightning, tornadoes, extreme hot/cold weather, etc.)

Leader Actions: Ensure the DD 2977 is updated with the appropriate controls. Ensure the Drill Sergeants are aware of forecasted weather and where to take shelter if required.

Low - Hyponatremia.

Assessment: Review the symptoms of Hyponatremia.

Controls: The Drill Sergeants will monitor the Trainee's water consumption and ensure the safety brief includes the symptoms of Hyponatremia.

Leader Actions: Ensure the DD 2977 is updated with the appropriate controls. Ensure the Drill Sergeants have relevant information prior to the safety brief.

Low - Interactions with poisonous plants.

Assessment: Check local listings of potentially hazardous plants.

Controls: The Drill Sergeants will give a detailed safety brief to include what types of poisonous plants are in the area, (i.e., Sumac, poison oak/lvy, etc.). The Drill Sergeants will ensure the Trainees are avoiding any identified poisonous plants.

Leader Actions: Ensure the DD 2977 is updated with the appropriate controls. Ensure the Drill Sergeants have the appropriate information prior to the execution of training.

Low - Interactions with local wildlife.

Assessment: Check local listings for dangerous/protected wildlife.

Controls: Ensure the Drill Sergeants provide a detailed safety brief prior to the execution of training to include what potentially hazardous/protected animals and insects could be in the area. Drill Sergeants will always monitor the Trainees.

Leader Actions: Ensure the DD 2977 is updated with the appropriate controls. Ensure the Drill Sergeants have the appropriate information prior to the execution of the training.

Environmental

Considerations

IAW the current environmental considerations publication, and ensure students are briefed on hazards and control measures.
